The international Maritime Dangerous Goods Code (IMDG) regulate them for ocean transportation under Special Provision A123 which says: Batteries, dry, containing corrosive electrolyte which will not flow out of the battery if the battery case is cracked are not subject to the provision of this Code provided the batteries are securely packed and protected against short-circuits. Example of such batteries are: alkali-manganese, zinc carbon, nickel metal hydride and nickel-cadmium batteries. Such battery have been packed in inner packaging in such a manner as to effectively prevent short circuit and movement that could lead to short-circuit.
